

Dear TCC Retiree,

Retiree Option Period – IMPORTANT UPDATES

Retiree Option Period is the time of year when plan changes are announced for the following calendar year. It is also an opportunity to change plan options, drop coverage, update beneficiary information, or in the case of vision, add coverage.

Please see important updates below that are effective for plan year 2025:

- TCC will be moving to the State medical, dental and vision plans effective 1/1/2025.
- Retiree medical, dental, and vision premiums will be deducted directly from the retiree's OTRS pensions.
- All retirees are required to complete an enrollment form for the State of Oklahoma insurance
- If you are enrolling in one of the Medicare Supplemental Plans, you need to complete the form titled *2025 Med Supp App* and if you are enrolling in one of the MAPD Plans, you need to complete the form titled *2025 MAPDApp*.
- Deadline to return Enrollment Form to Human Resources is November 8th

If you are currently enrolled in TCC Retiree Life Insurance:

- Please complete the attached Retiree Life Insurance Form.
- Retiree life insurance will remain with Blue Cross Blue Shield for 2025.
- Navia will continue to be the billing collector for retiree life insurance premiums. If you are enrolled in retiree life and have already set up your ACH, no action is required on your part. The ACH will roll over to the new plan year.

We will be hosting in-person Option Period meetings on October 29th at the Metro Campus in the Student Union, room 102 Film Lecture Room. There will be two sessions available, 9:00 – 11:00 am, and 1:30-3:30 pm.
