



Dear TCC Retiree,

It is that time of the year again – ***Retiree Open Enrollment!***

Retiree Open Enrollment is the time when plan changes and/or premiums are announced for the following calendar year. It is also an opportunity to change plan options, drop coverage, update beneficiary information or in the case of vision, add coverage!

**\*This is not a passive enrollment. We are requiring all retirees to complete and return the enclosed enrollment form, even if you are not making any changes. \***

Retiree Open Enrollment will begin October 9, 2023. The deadline to make any changes to your current plan elections is November 3, 2023. Human Resources must have your enrollment form by **November 3<sup>rd</sup>** for plan election changes to be processed.

Human Resources is pleased to announce that we will be hosting an in-person Retiree Open Enrollment Informational Session on October 17, 2023. The session will be held from 10:00a.m. to 11:30a.m at Metro Campus, Room MP110.

**Plan Information** If you are currently enrolled in one of the three Aetna Medicare retiree plans, you will not see changes in your medical coverage for 2024. However, we did have increases for the High premiums, Low premiums, and High Script premiums.

Below are the new 2024 medical premiums:

	<b>Retiree Only</b>	<b>Spouse</b>
Aetna Medicare High Plan:	\$438.86	\$438.86
Aetna Medicare Low Plan:	\$347.97	\$347.97
Aetna Medicare High Script Plan:	\$210.66	\$210.66

If you are currently enrolled in one of the BlueCross BlueShield Dental plans, there are no plan design changes, only a slight premium increase. There are no plan design changes for the BlueCross BlueShield Life Insurance or the MetLife Vision plans. Please see premium costs on the enrollment form.

We will be continuing with Navia as the retiree billing administrator. TCC strongly encourages retirees to sign up for ACH payments through Navia to ensure uninterrupted service. If you have already set the ACH up for 2023, no action is required for 2024, it will roll over to the new plan year.

Just a friendly reminder, if you are currently enrolled in a Life Insurance policy, we always recommend that you keep your beneficiaries up to date. Please enter your beneficiary information on the enclosed enrollment form. If you need to update your beneficiaries outside of Open Enrollment, you can either print and complete the beneficiary form posted to the retiree website [www.tulsacc.edu/retiree](http://www.tulsacc.edu/retiree) or email [benefits@tulsacc.edu](mailto:benefits@tulsacc.edu) to request a form be mailed to your home address. The most recently dated beneficiary form TCC has will be the beneficiaries the life insurance is paid out to.
